#### Dogs ACT & ACT Government

We understand the concern from our Members about the current situation with our organisation & the ACT Government. As reported several times Dogs ACT have met with Government representatives & discussed the issue of having some form of discount for our Members so that we can continue our sports without immense costs for registering our dogs with them. Dogs ACT meets & contacts their representatives at least every month but we are unable to bring you any further news at the time of this newsletter.

The Government wanted to bring in amendments to the Animal Welfare Bill, which have they have now done – you may remember seeing that the ACT now states that animals are 'sentient' beings – this took priority over other issues, one of which was our discount for Members.

As this issue has been continuing for some time Dogs ACT has also asked for an amnesty for Members. The latest news we have is that the information will be forthcoming very soon but until such time Dogs ACT cannot add to this.

### News from the ANKC

**CACIBs** – Now that Members are travelling to shows which offer CACIBs, it is timely to let those Members know the procedure for claiming their International Titles.

CACIB shows are listed on the ANKC website ( http://ankc.org.au/Event/?id=3035 )

The Rules for CACIB shows can be found in Regulation 5 Show, Section 6, which indicates the procedures, 10 groups & placings & that to qualify for a CACIB the dog must be over 15 months of age, amongst other information.

The administrative procedure for Application of International Champion Title with the FCI is located on the ANKC website under Miscellaneous at <u>http://ankc.org.au/AboutUs/?id=1183</u>

All paperwork & certificates must come to the Dogs ACT office to process in the first instance, however the ANKC documentation is clear on each step of the process.

#### Canberra's bushfire situation - information

To all **ACT** members - now that the bushfires are temporarily out, but were getting close to Canberra suburbs & potentially likely to impact our ACT members, here are a few emergency numbers you might need – for the future. Dogs ACT will not post information every 10 mins but info which is important for you should the fires be an issue again, so keep them handy.

SES - 132 500; Evoenergy - 131 093 (electricity) or 131 009 (gas); Icon water - (02) 6248 3111 (water & sewerage); Access Canberra - 132 281; Lifeline - 131 114; ACT Wildlife - 0432 300 033 (injured wildlife); Transport Canberra & City Services - 132 281 (storm water); & of course Emergency - 000.

When the ACT Government enacted the ACT Recovery plan, they activated 3 evacuation centres for those requiring support. Again, for future use, they would be:

- Erindale College, 115 McBryde Cres, Wanniassa 2903
- Hedley Beare Centre, 51 Fremantle Drive, Stirling 2611
- Dickson College, Phillip Ave, Dickson 2602
- You should also be aware that EPIC has been activated for people evacuating with horses.
