

DOGS ACT CONFORMATION JUDGES' TRAINING COURSES 2020

Applications are invited from DOGS ACT members to undertake training courses in 2020. The following courses are being offered:

- Conformation Aspiring Judges' Training course for those who wish to gain entrance to the Trainee Judges course; and
- Conformation Trainee Judges' Training course to become a licenced judge in their first, a subsequent Group or for a single breed.

Applicants should familiarise themselves with the conditions of participation and entrance criteria. Please ensure you have read the Dogs ACT Conformation Judges' Training and Examination Policy and [Course Structure Flowchart](#) before you apply.

The Trainee Judges' Course

Subject to applications received and the availability of suitably qualified Group Coordinators, Groups 1,2,3,4,5,6 and 7 may be available.

The Trainee Conformation Judges' Training course runs over two years. The theory component consists of Sub-Groups 1 and 2, each of which is presented every second year. In 2020, Sub-Group 2 will commence in February with breed lectures and a Sub-Group theory test will be held in July. An application is required annually to commence or continue a course.

Trainees who have successfully completed all the course requirements may apply to sit a practical exam that will be held in the second half of the year. Trainees who are already eligible to apply for a practical exam are strongly encouraged to enrol in the Course.

The Aspiring Judges' Course

The Aspiring Conformation Judges' Training course will commence in the first half of 2020 to prepare applicants for entry into the 2021 Trainee Conformation Judges' Training course.

To pass the Aspiring Judges course the following requirements must be met:

- Attend lectures on Terminology, Anatomy, Rules and Regulations;
- Attend supplementary seminars and field training activities;
- Steward on six (6) occasions; and
- Pass a theory exam and a practical competency exam.

Aspiring Judges must also pass a Group Entrance exam for their relevant group prior to enrolling as a Trainee Judge.

To Apply

Applications are made by completing the appropriate form and paying to prescribed fee of \$100 per course. Supporting statements and/or documents may be required to support an application.
