<u>FOR ALL CLUBS</u> –All Club secretaries have been sent a copy of a draft Covid-19 Template, which is to be used when holding events on Dogs ACT grounds. It is compulsory to submit your completed template with your schedules and advertisements when applying for shows on the <u>Dogs ACT grounds only</u>. If there is no Covid plan in place and approved by the ACT Government, prior to any event, we are unable to hold events on the grounds.

*Your COVID PLAN* – Do not be put off by having to complete the Covid-19 plan, its an easy document to complete and since the start of the year restrictions have eased. Dogs ACT has their own QR code so that's what exhibitors must check in with or put their name and details on a sheet of paper. Both forms of check in can be done at each of the two gates so once an exhibitor has passed through, they are good to stay. We don't advertise for the general public to attend so that we can have less than 500 people in attendance but if the Royal Canberra show managed to get through the weekend of shows, then your club can also. Why not rethink your shows for this year and if you have any questions, please contact the office?

# From the Office

For those Affiliates holding shows, please know that if you hold your shows at the same time as an event on the EPIC showgrounds which requires the use of Bicentennial gardens for campers, that your Club will not be required to clean the facilities block near the office. This will be undertaken by EPIC cleaners.

What you need to remember for running shows in 2021 & beyond.

The meeting room, kitchen & ladies & gents' facilities are left clean for you so please clean them at the end of your events. Put all waste paper into the large skip bin located on the

roadside. Please turn everything off including lights (lights have one remain on at night), taps as some leak if not correctly closed, if you use the large commercial fridge, microwave, urn please do a last-minute check when you leave for the last time. The Office advises that all of these items were completed prior to the pandemic but with committees changing & shows starting up slowly some of the basics are being forgotten or not known. #### FCI NEWS

Have you heard of the <u>FCI</u>? FCI stands for Federation Cynologique Internationale which in English means an international (world) dog organisation, a federation of many kennel clubs. It is based in Thuin, Brussels; it started in 1911 and they put out information in English, French, German and Spanish. It has 99 members, associates and partners in many countries across the world and Australia is an associate member of this organisation. It was created to create uniformity in breeding, exhibiting and judging of dogs. To date the Kennel Clubs of the USA, Canada and UK are not members of the FCI.

For dog showing, the FCI has broken down all dog groups into 10, whereas Australia has 7 groups of dogs. They have a large number of dogs participating in dog sports which include all the Australian sports but also rescue dog teams where dogs compete to become the best rescue team, shepherd dogs compete in trials to reflect the tasks of daily work and others. They have initiatives such as FCI Youth, which supports and encourages young people across the globe as the future of all dog sports. They undertake research with member and non-member countries to ensure that dogs are protected globally and that everyone has fun with their animals. Did you know? For all those wine drinkers, did you know that there is a range of red and white wines from the "Barking Mad" winery. Seems the name was to pay tribute to the winery Dachshunds of the past and present who, upon hearing the truck rumble down the road laden with fruit went completely 'barking mad'....

A NZ airline has been doing repatriation flights to reunite pets with their owners from Canada. Cargo holds during the pandemic have been restricted & some pets have been separated from their owners for up to a year.

Research has indicated that the sago palm, also known as the plant of steel, is dangerous to dogs & can potentially cause liver damage. Other plants to watch out for are the peace lily, aloe vera, desert rose, ivy, jade, philodendron, asparagus & corn plants amongst others.

While we have all spent a long time thinking & talking about the virus & pandemics, it seems the Victorian government have been looking at alternate sites for quarantining people returning to Australia. One of the favourites is the animal quarantine complex at Micklesham. This is the complex within which all our pets come into Australia & spend a minimum of 10 days (up to 4 months depending on which country it has come from). It seems the site sits on 144 hectares & human cabins will not be near the animal area.

There has been a mountain of research on the kinds of stress workers are under & one office is being proactive by paying for a dog to be part of their workforce. The Public Prosecutors office (PPO) in Perth WA is spending approximately \$162,000 as part of their staff well-being programme. Guide Dogs WA are arranging for a properly trained dog & the costs cover vet bills, food, ongoing costs & support from their organisation. The PPO staff often deal with violent crimes, view horrific material & deal with unsavoury people which is the rationale given for this addition to their workforce.

As the majority of workers are going back gradually to their normal workplaces many refuge organisations are concerned about the current trend in animal dumping as animals don't fit into their old & now renewed daily life.

### Show news

Now that the year has begun, we are now on the way to having clubs run shows and trials as usual. Every club using the Dogs ACT grounds must complete a Covid-19 plan which we hope will encourage them to start up their shows for 2021. Each Club has been sent a template to use from Dogs ACT to make paperwork easier. Clubs are to submit their Covid-19 plan when they submit their schedules and adverts.

The Kennel Club (UK) has advised that the Old English Sheepdog as a breed are declining severely in numbers in the UK & as such have been classified as a 'vulnerable' breed. When

the breed was known as the mascot for a well-known paint brand in 1979 there were 6,000 pups registered but in 2020 there were fewer than 300 registrations, making it the lowest number in 60 years.
