**Prizes:** 1<sup>st</sup> place, 2<sup>nd</sup> place, and 3<sup>rd</sup> place and ribbons for qualifying scores.

Presentations will commence at the conclusion of the trial.

**Other:** Competitors must only submit one entry for each class/element. If there is more than one dog for a class, then the application must nominate the name of the additional handler, who will be run sequentially.

It's the competitor's responsibility to enter only the classes they are eligible to enter. Refer to s6.1 Titling Classes and s6.2 Progression through the Titling Classes of the 'Rules' (specifically s6.2.2 and s6.2.3) re eligibility requirements for entering a trial.

Competitors should not visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk losing the opportunity to use these locations in the future.

No odour is to be brought/used on the trial grounds by competitors.

Competitors must park, crate and walk their dogs in the designated areas only, any competitors found out of bounds when not running a dog may be asked to leave the event.

No bitches on oestrus are permitted at the trial.

**Ribbons** for 1st place, 2nd place, and 3rd place, and for qualifying scores.

The club reserves the right to make any changes that will ensure the smooth conduct of the trial, to substitute or appoint additional judges, to accept or reject entries and to adjust the starting times. Dogs ACT regulations allow contracted judges to compete in trials provided that they don't do so in the classes that they have been contracted to judge.

**COVID-19:** These trials shall be conducted in accordance with the recommendations of ACT Health, Dogs ACT and the ANKC, and any additional requirements of this club which will be available on the Club's Facebook page and will be made available to all entrants. All officials, competitors and attendees shall agree to abide by the recommendations relating to the conduct of the trial and agree to follow the directions of Club Officials in relation to enforcing the requirements.
