Other:

Competitors should submit only one entry for each class/element they are eligible to enter. If you are running two dogs in the same class, then please specify the second handler's name on your entry form. Competitors from the same household will run back-to-back.

It is the competitor's responsibility to enter only the classes they are eligible to enter. Refer to s6.1 Titling Classes and s6.2 Progression through the Titling Classes of the 'Rules' (specifically s6.2.2 and s6.2.3) re eligibility requirements for entering a trial.

Competitors should not train or bring any scent onto the BDOC grounds within two weeks prior to the trial date. Many search locations are real-life environments and as such visiting these areas may risk contaminating the area or losing the opportunity to use the locations for future events.

No odour is to be brought or used at the trial by competitors on the day. Competitors **must** park, crate and walk their dogs in designated area only. Please note that competitors not adhering to these rules may be asked to leave the grounds.

For the safety of all competitors, please ensure that your dog is on lead at all times including leaving your vehicle, the paddocks will be <u>unavailable</u> to free run your dogs due to the exterior elements being offered and line of sight issues. Only dogs who have entered the search area where an off lead option is available are permitted to run off lead.

No bitches on oestrum are permitted at the trial.

The club reserves the right to make any changes that will ensure the smooth conduct of the trial, to substitute or appoint additional judges, to accept or reject entries and to adjust the starting times. Dogs ACT regulations allow contracted judges to compete in trials provided that they don't do so in the classes that they have been contracted to judge.

COVID-19: Please do not attend the trial if you are unwell or have recently tested positive for COVID, we value our competitors and volunteers, please don't make them unwell.
