**Awards:** 1<sup>st</sup> place, 2<sup>nd</sup> place, and 3<sup>rd</sup> place and ribbons for qualifying scores. Presentations will commence after each class is completed.

**Other:** Competitors will need to submit one entry for each class/element. If you are running two dogs in the same class, then **you will need to specify the second handler's name** on your entry form. We will try and run competitors from the same household back-to-back.

It's the competitor's responsibility to only enter classes that they are eligible for. Refer to s6.1 Titling Classes and s6.2 progression through the titling classes. 'Rules' (specifically s6.2.2 and s6.2.3) for eligibility requirements.

No odour is to be brought or used at the trial by competitors on the day. If you have accidentally brought odour with you then please advise the trial manager immediately or a BDOC representative so it can be adequately stored during the trial.

Competitors **must** park, crate and walk their dogs in designated areas. Please note that competitors not adhering to these rules may be asked to leave the club grounds.

**For the safety of all competitors, please ensure that your dog is on lead at all times including leaving your vehicle. Only dogs who have entered the search area where an off-lead option is available are permitted to run off lead.** If your dog is reactive consider where you park AND consider if your car needs additional screening to minimise triggers.

No bitches on oestrus are permitted at the trial. BDOC reserves the right to have dogs vetted.

The club reserves the right to make any changes that will ensure the smooth conduct of the trial, including to substitute or appoint additional judges, to accept or reject entries and to adjust the starting times.

Dogs ACT regulations allow contracted judges to compete in trials provided that they do so in classes that they have not been contracted to judge for.

**Health:** Please do not attend the trial if you or your dog is unwell or have recently tested positive for COVID-19 or any other infectious diseases. We value the health of our competitors, volunteers and our canine companions and would like to keep them healthy and safe. Thank you.
