Additional Information:

- A separate entry form must be submitted for each entry (Scent Work Rules s.8.1.2).
- Handlers must only enter the classes they are eligible to enter (Scent Work Rule s6)
- **No upgrades will be allowed after the trial closing date.**
- At any trial a dog may be entered in only one (1) class within an Element (s8.1.3)
- Only one dog / handler per Class/Element. An owner entering two dogs in the same Class/Element **MUST** advise the name of a second handler (who is current and financial with a member body). Dogs from the same family will run concurrently.
- Handlers should not visit the trial location in the two weeks prior to the trial date
