Saturday 19 September 2026

Entries decided by Ballot

Class: 100m Sprint.

Ballot closes midnight Thursday 27 August 2026. **No Changes or Refunds** on entries after 5pm 11 Sept 2026.

Entry fee: \$22.00.

Online entries only, via Showmanager (**Registry dog only**)

Part A (restricted) – entries capped at 50 dogs, restricted to people living within the area identified in the attached map (see below) and limited to two entries per person (household / showmanager profile)

Part B - capped at 50 dogs and limited to two entries per person (household / showmanager profile)

Judges: Elaine Temby (ACT) and Maelyn Draper (ACT)

Lure Drivers: Helen Mosslar (ACT) and Belinda Mitchell (NSW) (Trainee drivers)

These trials will be using a continuous lure and have an enclosed catching pen 30m long

Check-in: 8.15 to 8.50am. Anyone not checked in will be marked absent.

Measuring Dogs: 8.15 to 8.50am. Owners will need to fill in the height card before presenting the dog for measurement. Blank height cards will be available on the day.

Vetting: There will be no vetting at check-in, but organisers reserve the right to vet any dog if it deems necessary.

Judging starts: Not before 9.30am, maybe delayed due to fog or frost.

Run Order: Run 1 Part A then Part B, followed by Run 2 in the same order.

Catalogue / running sheet: provided free on the Canberra SprintDog Facebook page.

****Important additional information (Please read).**

Ballot system

- **Dogs must have their showmanager profile linked to the Dogs Aust registry to be entered.**
- The Main Officials dogs are not included in the entry cap number.
- Ballot will close midnight (AEDT) 27 August 2026 and be drawn the next day.
- Once the draw has happened, everyone will receive an email advising if they are successful or unsuccessful. A maximum of 2 dogs will be allowed per person / household.
- If successful you will need to complete your entry and pay by 7pm 3 September 2026.
- Unpaid entries will be removed and a new ballot done to fill vacancies.
- No changes / withdrawals / refunds after 5 pm 11 Sept 2026.
- Ballot success is **NON-TRANSFERABLE** – if you decide you no longer want to attend the trial, you can't give or sell the spots to someone else. The Ballot will be used to reallocate vacant spots.
- Entries breaching the rules may be rejected from the ballot.



- All dogs will run in the first round. Dogs that do not complete the course, will not be eligible to compete in the second round.
- Exhibitors to bring their dogs height card. Dogs without a card to be measured at check-in.
- Exhibitors need to arrange their own handlers and those handlers must be financial members of their state member body. Handlers must be over 16 years of age.
- Exhibitors should enter the name of their handler/helper in showmanager to aid with cataloguing.
- Bitches in season are not allowed to compete or allowed on the club grounds.
- Bitches must be a minimum of 10 weeks post whelp to compete. Mated bitches or bitches in whelp may not compete.
- **The organisers reserve the right to make any changes to ensure the smooth conduct of the trial.**
- **The organisers reserve the right to accept or reject entries.**
- **This trial is run under the rules & regulations of Dogs ACT.**
- Entries into Part A are restricted to people living within the area identified below (110km from Canberra City) plus anyone living in the south coast area from Batemans Bay to Eden (includes Cooma to Bega) (the address listed in showmanager will be used to accept or reject entries).
